	<p><b>The Text Dependent Analysis (TDA)</b> is an essay scored with a holistic <a href="#">rubric</a> with a point range of 1(lowest) to 4(highest). To reflect the importance of student-produced writing, the score on the writing is then weighted by a factor of 5 for a maximum of 20 points.</p>
